## Township of Helena Board of Supervisors | Regular Monthly Meeting New Prague Fire Conference Room | 7:00 PM • May 4, 2017

### Call to Order

The Regular Monthly Meeting of the Helena Township Board of Supervisors was called to order at 7:00 PM by Chair Wermerskirchen at the New Prague Firemen's Conference Room. Pledge of Allegiance was said.

#### **Minutes**

On a motion by Nytes/Wermerskirchen the Minutes from the April Regular Monthly Meeting and Workshop were approved as presented; carried 2:0:1 (Deutsch).

## 255<sup>th</sup> Street Ditch Maintenance

Tom Walerius and M/M Larry Hendricks were present to raise concern about the ditch work done on the south side of 255<sup>th</sup> Street West. Specifically, they were concerned their property will receive water from the south side of the road. Officers explained this work was routine maintenance and was ordered because the old existing culvert was filled in with silt and not working as originally designed to ensure road bed stability. Nytes suggested Walerius and Hendricks work with SWCD on their concerns as there are funds available for water issues. Walerius and Hendricks stated they wished they had been notified prior to the work. Wermerskirchen communicated with Walerius during the project.

  - 4. Nytes reported Ivan Kohout indicated the Baseline is in the best shape it's been for as long as he'd lived in the area and extended appreciation to the officers and contractor

#### **Road Overseer**

Perkins reported the following:

- 1. Rynda was notified of park quote being accepted and herbicide application was ordered from Quality Green
- 2. Cold patching was completed for Juniper and WCLD
- 3. The tree was removed from 255th and removed by landowner
- 4. Snow plow damaged the curb near the shared access lot on Willow Lane; Perkins will make repair
- 5. Perkins was contacted by a resident building a new home on WCLD; property owner needs a driveway permit because he is not using the existing drive

- 6. Quotes were reviewed for work on Koepper, SM Drive, 255th and Willow Ct.
- 7. Alton Avenue is being monitored for water levels affecting the safety of the traveling public

On a motion by Deutsch/Nytes the Koepper crackfilling and sealing was accepted at \$3,154; carried unanimously.

The remaining projects were tabled until all spring maintenance projects are completed, or final quotes received to ensure adequate fund availability.

#### St. Benedict

The ditch on the south side of 250<sup>th</sup> by Clif Ebert is the next maintenance project and will be directed by Project Manager Nytes. Ebert expressed appreciation for the township addressing this issue.

Nytes reported it has been too wet for start the prject; once the weather is good, the ravine project is ready to commence.

Maas explained Trnka had been ill and the completion of the work was delayed. Trnka intends to complete everything the week of May 8, 2017. Maas is working with Pete Schmitt from Scott County related to tank decommissioning and reminded the board that the recent fee from MPCA was agreed that the township will pay one last payment I 2017. Officers expressed appreciation to Maas for continuing as the Project Manager.

RSP2 Ravine project completed; two follow up items related to the material application and road patch will be completed shortly by Johnson. The culvert work was directed by Acting Project Manager Deutsch.

SSD decommission is not finalized yet. The county is considering starting up the system for county use.

RSP2 park swing set was ordered; will be installed by park maintenance (mowing) contractor.

MAT's short course is being considered by Deutsch and Wermerskirchen.
