Minutes of December 2, 2021 | New Prague Fire Hall

Call to Order

Regular Monthly Meeting was called to order by Chairman Deutsch at 6:30 PM.

Present:

Chairman Duane Deutsch, Supervisor Ed Nytes, Treasurer Nathan Hutton, Supervisor John Wermerskirchen, Deputy Clerk Jody Deutsch, Road Overseer Jeff Haag and Clerk DeAnn Croatt. Also present: Nathan Abney from the Scott County Trail Master Planning.

Road

1. Johnson completed the ditch work on WCLD

Overseer Report

2. Caselius' comments related to a dissatisfaction of the seeding contractor was shared with the contractor; the contractor will come out in spring to touch up any areas needed

Scott County Trails

Nathan Abney, representing trail planning for Scott County's Regional Trail System, was present to review project and ask for a township representative on the Technical Team, and asked the township to encourage one or two residents to apply for a position on the Community Design Team. This will be added to the township's website and Hutton will communicate with the local Boy Scout Troop Leader. Jeff Haag was appointed to represent the township on the Technical Team. The teams sunset June 2023.

Minutes

On a motion by Wermerskirchen/Nytes the November Regular Monthly Meeting and Workshop Minutes were approved as presented; carried unanimously.

Old Business

Solar Escrow

Scott County and Attorney Fenske indicated solar escrow funds may be refunded to the respective companies. Clerk will obtain the correct mailing addresses for both US Solar and Geronimo, with refunding scheduled for January 2022.

250th

Deutsch reminded the officers that 250th is in pretty tough shape. The project has been tabled because of the cost to the township and a consideration by the engineer to reclaim the bituminous surface. MAT is lobbying so townships may use ARPA funds for road projects, so the township will be following that closely.

New Business

MarDen

The Feasibility Report for MarDen Court was reviewed. After consulting with Attorney Ruppe and Engineer Vistad, it was determined to hold to a policy of the township funds paying for 50% of the project, with the balance of 50% being specially assessed to the abutting landowners.

Because of the estimated costs of the overlay, a minimum of two quotes are needed; bids are not necessary.

On a motion by Deutsch/Wermerskirchen, by Resolution 120221 "Accepting Feasibility Study and Calling for a Public Hearing on the Improvements for MarDen Court" the Feasibility Report for a MarDen Court Overlay was accepted, contingent upon Attorney Review; carried unanimously. The hearing was set for 6:30 PM Wednesday January 19, 2022 at the NP Fire Hall Conference Room and via ZOOM and phone. Clerk will publish, post and mail as required.

The total cost of the project is estimated at \$73,840. \$36,920 will be paid with township funds; \$36,920 will be specially assessed at not to exceed \$5,274/lot within MarDen Court and abutting MarDen Court roadway.

On a motion by Wermerskirchen/Nytes the Clerk is authorized to fully execute the necessary documents; carried unanimously.
